Designation Rules:

1. Complete designation form, W-9 and submit fee together. Horse must have a PTHA registration.
2. Include a copy of the horse's Pinto registration papers. **COLORED COPY OF REGISTRATION PAPERS MUST BE PRESENTED AT THE GATE IN ORDER TO SHOW.**
3. **All Age Walk-Trot Participants must have a current Walk-Trot Card in their respective divisions/associations.**
4. Pay the \$300 designation fee by July 15<sup>th</sup> or \$400 by August 15<sup>th</sup> of year you plan to show to be eligible in the Midwest Cash Incentive Challenge classes for that year. The designation fee is paid each year you plan to show the horse. Class fees payable at show.
5. Every horse must be designated to show in any part of the Midwest Cash Incentive Challenge
6. Horse must be born or bred by individual who lives in the Midwest (as defined). This will be verified by registration papers showing breeder and/or original owner residing in the Midwest.
  - a. Midwest is defined as: Iowa, Illinois, Indiana, Michigan, Nebraska, Minnesota, Wisconsin, Kansas, Missouri, South Dakota, North Dakota, and Colorado.
7. Current owner must live the defined Midwest states
8. Exhibitor must live in the defined Midwest states
9. Exhibitor may not be on the 2024 NSBA open or Non-Pro Riders list per NSBA qualifications.
10. The designator's name must match the name associated with the social security # or Tax ID # submitted.
11. Exhibitors must be in good standing and have current membership with their respective National Breed Association AND either Nebraska Paint, Nebraska Quarter Horse or Iowa Pinto.
12. Pay \$75 entry fee at show for each class you plan to enter
13. If you are designating a horse that the stallion nomination has been paid, all foals by stallion are eligible to be designated at a reduced rate per the deadlines- \$250 by July 15 and \$350 by August 15<sup>th</sup>.
14. Make checks payable to Midwest Cash Incentive Challenge.
15. Credit Card payment accepted with a 4% convenience fee.
16. Designation fees are non-refundable
17. Designator authorizes Midwest Cash Incentive Challenge to use above horse and exhibitor in advertisements, social media and marketing for this program.
